RULES & REGULATIONS

1. RULES & REGULATIONS Application Completion:

- All participants must complete the application form provided by the Iberian Sales Horse Exposition (the "Sales Expo") accurately and truthfully and submit recent x-rays, photos & videos, or links thereof.
- o Incomplete applications will not be considered for entry into the Sales Expo.
- o There are limited spots in the Sales Expo, and, as such, the organizing committee cannot guarantee acceptance of your sales horse after spots are filled.
- o The individual signing the application is 18 years of age or older.
- You certify that the information provided in the Iberian Sales Horse Application is accurate to the best of your knowledge.
- You agree that the Sales Expo Rules and Regulations, together with the Sales Expo Application, become the entire Sales Expo Agreement, unless modified per the Sales Expo Rules and Regulations.
- The Sales Expo committee reserves the right to amend or update the rules and regulations of the Sales Expo event at any time. Participants will be notified of any changes in a timely manner.

2. Entry Fee:

- An entry fee of \$650.00 is required for each sales horse entry that is accepted into the Sales Expo.
- The entry fee covers stabling in the Sales Horse Gallery for the duration of the event, Oct 18-20, and your advertisement on the Jumbo Screen during your 6minute presentation.
- Entry fees must be paid in full by the specified deadline to secure participation in the event.

3. Horse Eligibility:

- o Only pure Iberian horses are eligible to participate in the Sales Expo.
- Sale horses must be registered with a recognized breed association or registry to be eligible for entry.

4. Health Requirements:

- All participating horses must have up-to-date health certificates and vaccinations as required by WEC protocol. (Please refer to the attached WEC health protocol document)
- Any horse showing signs of illness or contagious disease will be disqualified from participating.

5. Behavior and Safety:

- Sale horses must be well-behaved and manageable during the event and in the barn.
- o Handlers are responsible for maintaining control of their horse and ensuring the safety of themselves, other participants, and spectators.

6. Presentation Guidelines:

- Each participating sale horse will be allocated a 6-minute time slot for their presentation.
- Presentations may include either an in-hand or under saddle demonstration to showcase the horse's attributes.
- o A written script and music must be submitted at least 2 weeks in advance of the show to the Iberian Sales Horse Exposition show secretary.
- o Presentations must adhere to the schedule provided by the organizing committee.

7. Code of Conduct:

- Participants and handlers are expected to always conduct themselves in a respectful and sportsmanlike manner.
- Any behavior deemed inappropriate, including but not limited to harassment, discrimination, or disruptive conduct, will result in immediate expulsion from the event.

8. Liability:

- o All participants and handlers attend the Sales Expo at their own risk.
- o The Sales Expo, event venue, sponsors, and affiliates will not be held liable for any accidents, injuries, or damages that may occur during the event.
- o Iberian Horse Showcase, LLC ("IHS, LLC") and Iberian Spectacular Inc. ("ISI Inc."), and any, and all, of their respective affiliates, are not in any way participating in the sale of horse(s), and do not guarantee the quality or results of purchases of any sold horse (s) that may be associated with the Sales Expo.
- By agreeing to participate in the Sales Expo, you agree to hold harmless IHS, LLC, and ISI Inc., and any, and all, of their respective affiliates, licensees or agents, from any liabilities for any damage, injury or losses, personal or otherwise that may occur at the Sales Expo or thereafter in regard to your participation in the Sales Expo at the Iberian Horse Showcase.
- You guarantee that any sales contract that derives from your participation in the Sales Expo will indemnify IHS, LLC and ISI Inc. and any, and all, of their respective affiliates.

9. Compliance:

- Participants are required to comply with all rules and regulations set forth by the organizing committee of Sales Expo.
- Failure to comply with the rules may result in disqualification from the Sales Expo and forfeiture of entry fees.
